The Southeastern District Fall Meeting was held on October 18. Nearly 50 people were on hand to review past accomplishments and discuss plans for the future. Both the State President and 1st Vice-President attended. Each presented a speech relevant to the current status of the GFWC PA. The President was given a little red wagon containing a \$100 contribution for the St. Jude's project. In addition to this donation, \$50 was also collected for the project during the meal. The First Vice President distributed a survey sheet that would allow her to better prepare for the next administration. Two other State Board members also spoke. The Membership Chairman encouraged recruitment and retention of club women. The Fundraising Chairman promoted the few remaining items still available for this administration.

One of the highlights of the morning session was a presentation by the 2019 HOBY Candidate from Perkiomen Valley. Her speech was interesting and informative and gave clubwomen new insights into this outstanding program. The District Director talked about the past 124 - year history of President's Projects for the GFWC Pennsylvania. She included the top 10 fundraisers as well as several other interesting projects. Highlights were a Care Project to build schools in Central and South America and the reforestation of areas in North Central Pennsylvania with 100,000 new trees. She also applauded early clubwomen for their \$6,000,000 contribution to the war effort from 1941-1944. During the very early years, enthusiastic clubwomen had also campaigned for cleaner streets, TB tests, and community libraries. (Information for this speech was found in documents recently uncovered locally.)

Club and County presidents gave excellent presentations providing outlines of their recent fundraisers, club programs, and community activities. They reported on donations to libraries and scholarships for students. Conservation projects were also completed. By way of supporting the Seven Grand Initiatives, the additional GFWC Initiatives, and the five PFWC Initiatives, donations were made to Pennies for the Arts, Canine Companions, Bahamian Hurricane Relief, and the St Jude little red wagon project.

The clubs in the Southeastern District have continued walking in support of the President's Project and many are knitting hats, gloves, and scarves. New members are being recruited and interesting and exciting programs are being presented.

General Federation of Women's Club members were leading the charge for women's suffrage.

A group of club women marched in the 1913 Suffrage Parade on Pennsylvania Avenue in an effort to change the publics outlook on women's voting rights. Many leaders of the suffrage movement were GFWC members such as Carrie Chapman Catt and Jane Adams. Additionally, former GFWC presidents, Ellen Henrotin and Sarah Decker Platt encouraged women to speak out for equality to vote. Our organization formally endorsed the suffrage movement with a resolution in1914 "supporting political equality of men and women." Therefore, the current GFWC is for the passage of the H.R.1923 and S 2427 legislation. This legislation supports The Women's History and Nineteenth Amendment Centennial Quarter Dollar Coin Program Act. This is a way to honor those women from each state and the District of Columbia who had contributed to the suffrage effort. Please contact your legislators to support this legislation. There is a prewritten letter online under GFWC.ORG. Click on "What we do" and then on Legislation Action Center. Follow prompts to H.R.1923 information. Complete the form with your name and address and send.

Let us commemorate the women, whose hard work, got us the right to vote.

### DOMESTIC VIOLENCE AWARENESS AND PREVENTION

Do you know the difference between Smuggling and Human Trafficking?

**Smuggling** is a crime committed against a country and involves the illegal transport of an individual across a national border. It is always transnational.

**Human Trafficking** is a crime committed against an individual and does not need to involve the physical movement of a person. Trafficking victimization can be transnational or domestic. Human trafficking is a public issue that impacts individuals, families, and communities. Traffickers disproportionately target at risk populations including individuals who have experienced child abuse, sexual assault, gang violence, and/or have been runaway or homeless youth or persons displaced during natural disasters.

**How Victims are Trafficked?** Traffickers use force, fraud, or coercion to subject victims to engage in commercial sex or forced labor. To understand how victims are trafficked, a person needs to know the meaning of the words, action, means, and purpose as they pertain to human trafficking.

#### Action

*Recruiting* includes proactive targeting of vulnerability; *harboring* includes isolation, confinement, and monitoring; and *obtaining* includes forcibly taking or exchanging something for the ability to control.

#### Means

- 1. Force includes physical restraint, physical harm, sexual assault and beatings.
- 2. Fraud includes false promises regarding employment, wages, working conditions, love, marriage.
- 3. Coercion includes threats of serious harm to or physical restraint against any person, and shame and fear, inducing threats.

#### **Purpose:**

- 1. Commercial Sex Act is any sex act on account of anything of value given to or received by any person.
- 2. *Involuntary Servitude* is any scheme intended to cause a person to believe that, if the person did not enter into or continue in such condition, that person or another person would suffer serious harm or physical restraint.
- 3. *Debt Bondage* includes a pledge of services where an individual is trapped in a cycle of debt that the person can never pay down. Through controlling the victim with force, fraud and coercion, the human trafficker owns the victim's life for many years.

To update the Conservation initiative **Wands for Wildlife**: The website was checked recently. The response to Wands for Wildlife has been so great that they are now only accepting donations in October and February each year. If your club has some wands collected already, save them to send in February or continue the program until next October.

The group collecting **eye hook clasps** (from bra plackets) to help injured turtles was contacted about donations. The response from them said "Thank you for your interest in helping us help turtles. We have been overwhelmed with the generosity and responses and no longer need clasps." This shows the power of the internet and social media.

One recent article in the newspaper regarding conservation efforts was about detection dogs used to find **invasive plants**. A Labrador Retriever was trained to track down the yellow-flowered shrub Scotch Broom that displaces native plants with thickets impenetrable to wildlife. The non-profit New York-New Jersey Trail Conference began last fall to hunt for Scotch Broom in New York state parks.

There was a front-page article in the newspaper recently about the **spotted lantern fly**. Currently quarantine regulations have been imposed on 13 counties in Pennsylvania. If you do see the spotted lantern fly or its egg mass, you are urged to destroy it and report your sighting by calling 1-888-422-3284.
